Dear Maine State Police,

Our Company is conducting an equalization (revaluation) program for the Town of Sumner, Maine. The program will commence in August 2023 and end on September 2024. One of our responsibilities is to go to each property in Sumner. When we are at a property we ask to perform an exterior inspection of the buildings. We generally take one or more digital pictures at the property.

Our policy is to notify the Maine State Police. We are also notifying Troop B of the Maine State Police. We want everyone to know about our presence in Sumner and our reason for being there.

Each employee will have an identification badge, an identification letter on Town letterhead, or both. We will leave a door hanger notifying property owners who are not home that we have visited their property. The door hanger will have the Town Office's phone number for those who have questions.
